ORDER U/S 12AA OF THE INCOME TAX ACT, 1961.

The Society herein known as M/s. Kenneth Anderson Nature Society, No. 8, J D Plaza, Opp. To TNEB Office, Hosur tk, Krishnagiri Dist was created by Memorandum of Association made on 17<sup>th</sup> December, 2008 with the main objects such as (i) To promote awareness and appreciation of Nature in all its forms and manifestations (ii) To undertake and to aid the conservation of Nature and (iii) To actively encourage and undertake scientific study and documentation of nature and its life forms etc.,

2. The Society has furnished an application on 16/03/2012 in Form No. 10A, under section 12A(a) of the Income-Tax Act, 1961, seeking registration u/s. 12AA of the Income-Tax Act, 1961.

3. After due consideration of the objects of the Society, the genuineness of the activities carried out by the Society, the registration is hereby granted u/s. 12AA as **Public Charitable Institution**. The registration is hereby granted to the applicant Society with effect from the first day of the Financial Year in which the application has been filed i.e. 01.04.2011. The Registration No. of the Society is 86/2011-2012.

4. The applicant Trust shall abide by the provisions of section 139(4A) of the Act and all other provisions of the Act, as may be applicable from time to time.

5. If at any stage, it is found that the activities are either not genuine or are not being carried out in accordance with the objects, the registration granted may be cancelled, in terms of the provisions of section 12AA(3) of the Income-Tax Act, 1961.

6. However, mere registration u/s. 12AA does not enable the applicant, the exemption under the provisions of section 11 to 13 or any provisions of the Income-Tax Act, the Assessing Officer is free to make any inquiries in this regard as deemed fit.
